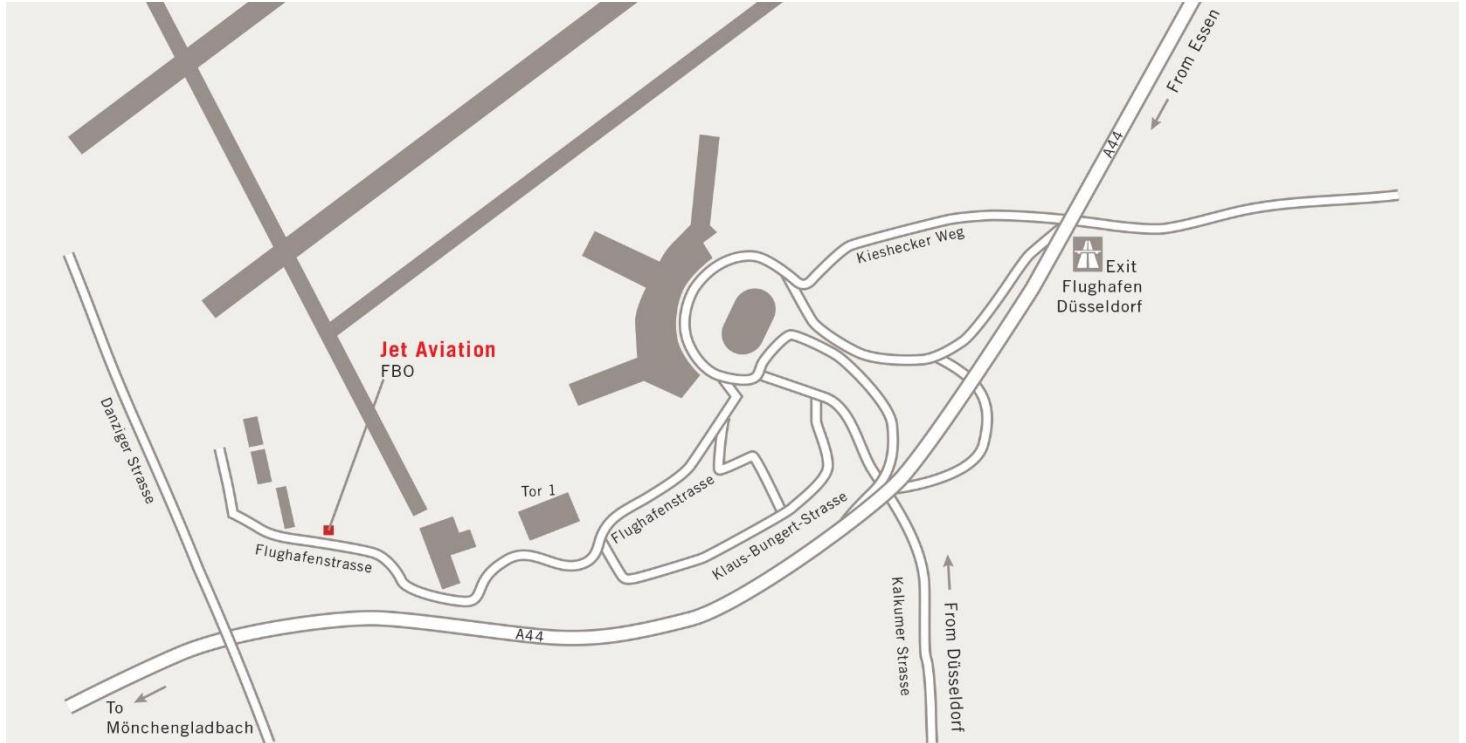

- Any kind of baggage handling by Jet Aviation employees

- Any transportation outside the GAT area

- Storage of any items for non handling customer
- Delivery of any storage items for non handling customer
- Landside transfer to the airport
- Mineral Oil exemption
